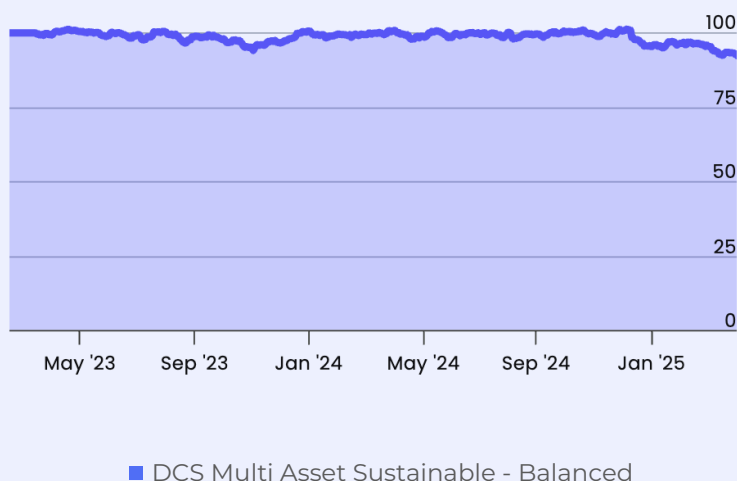


Fund objective

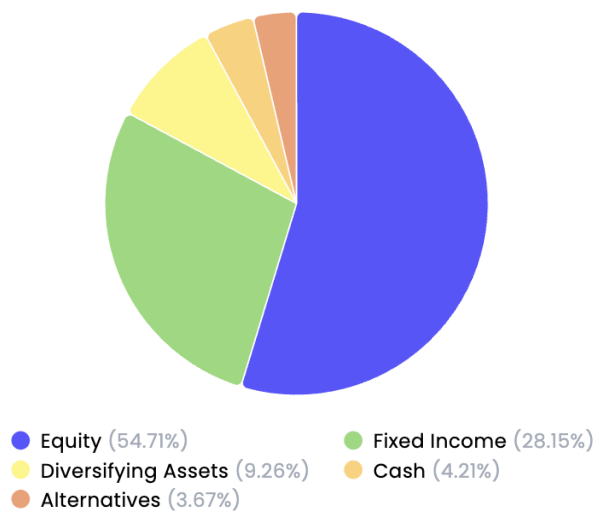

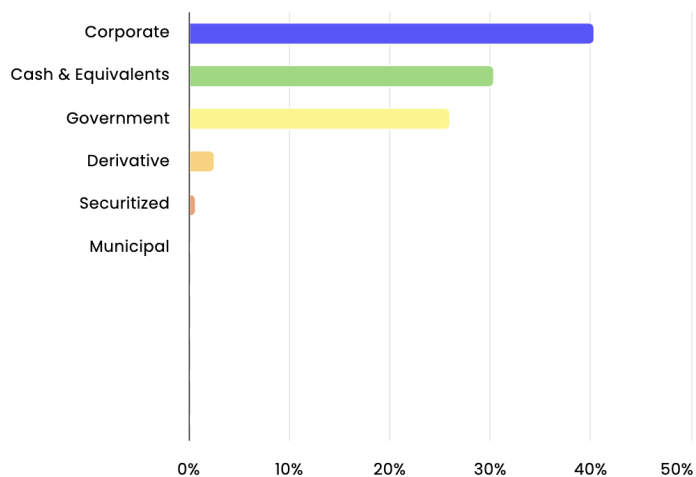

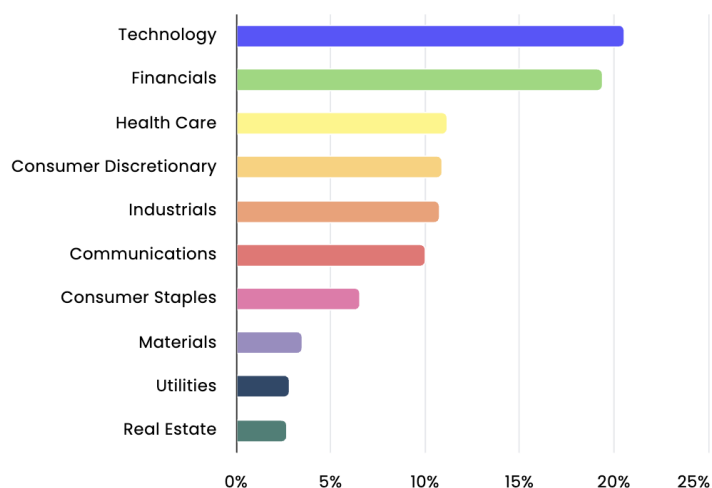
