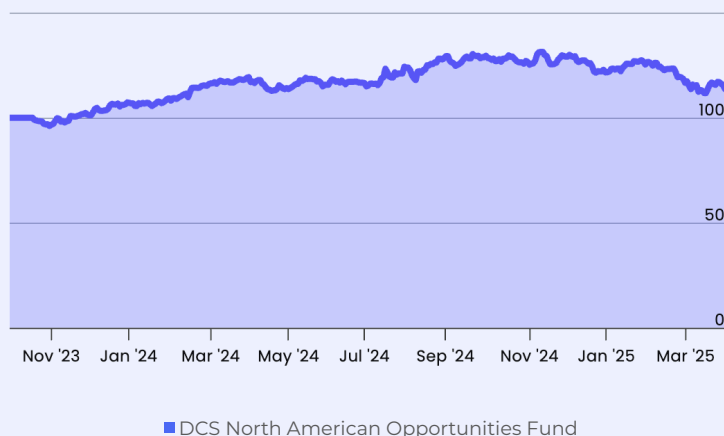


Fund objective

The Fund will be primarily invested in companies domiciled in the United States but may also take exposure to companies domiciled in Canada and, to a lesser extent, Mexico. Investments shall be in the shares, common stock or other equity instruments issued by such companies, although the Fund may from time to time invest in equity linked instruments (such as warrants, rights issues, convertible preferred shares and convertible bonds), depositary receipts, financial derivative instruments, other collective investment schemes or other instruments described in further detail herein. The Fund will typically invest in companies with a market capitalization greater than USD100 million at the time of initial purchase of the relevant security.

Companies whose market capitalizations fall below the market capitalization threshold after purchase will continue to be eligible holdings for the Fund, and the Fund may make additional purchases of those companies' securities.

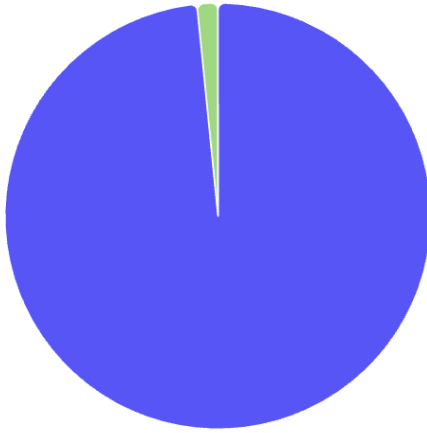

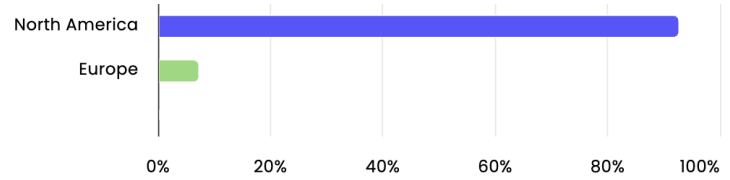


Security Types

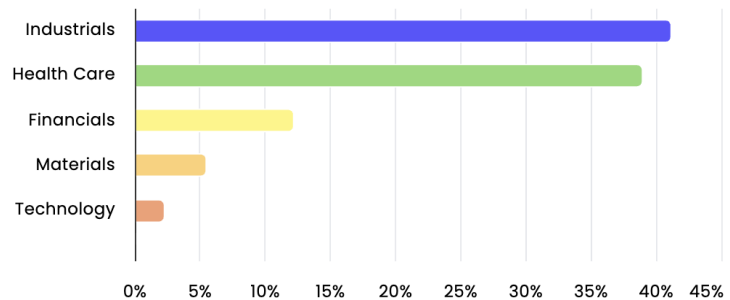
