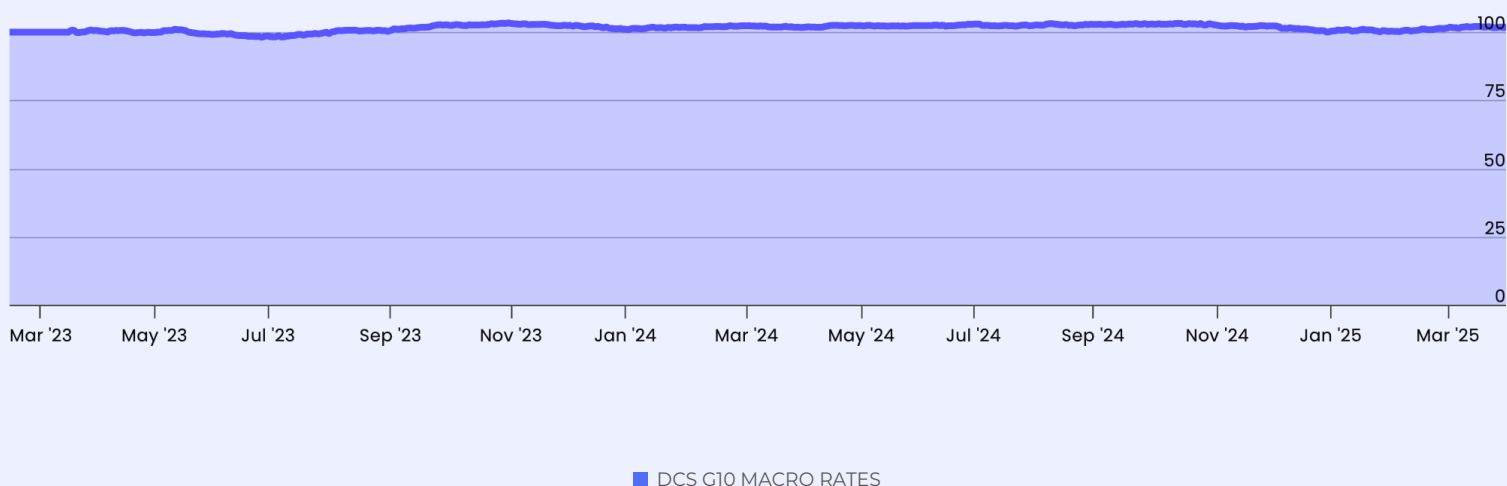


## Fund objective

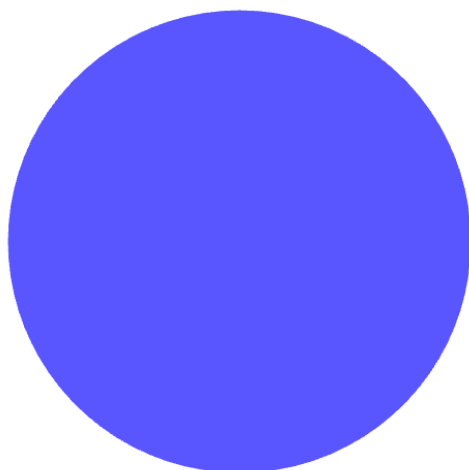

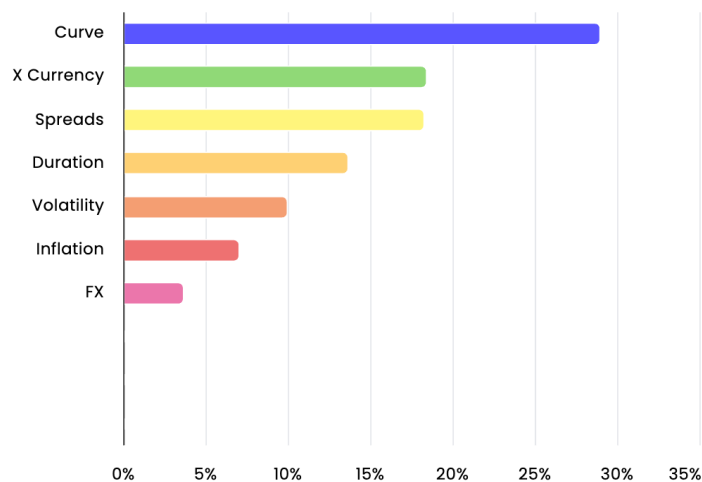

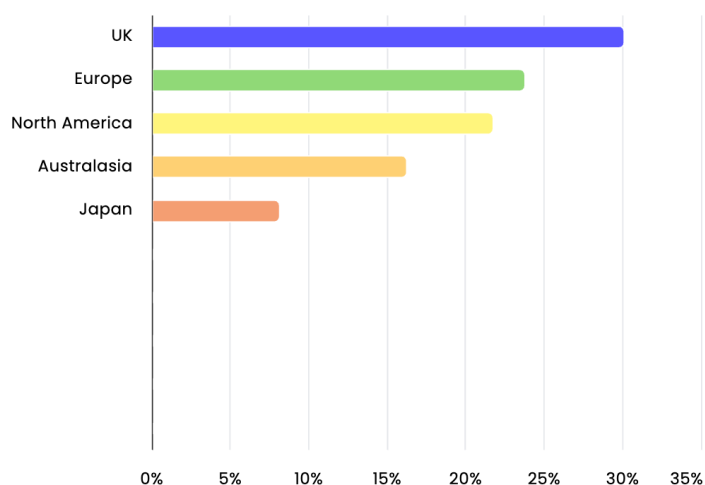
